



MD 97 Montgomery Hills Safety and Accessibility Project MD 390 Protected Bicycle Lane Project

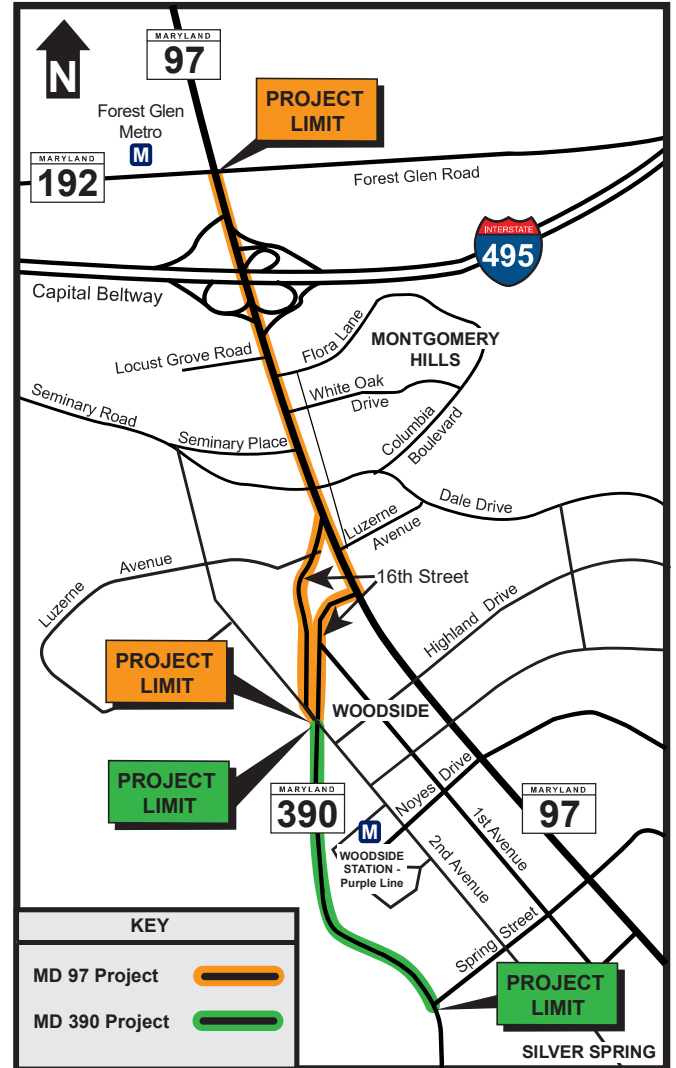
Public Open House Scheduled for July 31

The Maryland State Highway Administration (SHA) invites you to attend a public open house for the MD 97 (Georgia Avenue) safety and accessibility project and the MD 390 (16th Street) protected bicycle lane project in southeastern Montgomery County. The project team has advanced both projects since the last public meeting and will present the latest designs.

Project Overview

The MD 97 project is located in the Montgomery Hills community in southeastern Montgomery County. The project study area is centered around the 0.7-mile segment of MD 97 (Georgia Avenue) that extends from south of MD 390 (16th Street) to MD 192 (Forest Glen Road), including the interchange with the Capital Beltway (I-495) near the Forest Glen Metro Station. The scope of the project includes protected bicycle lanes from 2nd Avenue to the Forest Glen Metro Station; replacement of the reversible lane with a landscaped median and dedicated turn lanes; ADA-compliant sidewalks; interchange modifications; and a new signal at Flora Lane. Right-of-way acquisitions are underway, and utility relocations are expected to begin within the next six months. Construction is anticipated to start in spring 2028.

The MD 390 project is located in the Woodside community and connects Montgomery Hills to downtown Silver Spring. The project provides two-way protected bicycle lanes between the existing protected bicycle lanes in downtown Silver Spring and those proposed within the MD 97 Montgomery Hills project, while also providing a connection to the Woodside Purple Line Station. The MD 390 project is at 30 percent design, and the design is scheduled to be completed in winter 2026/2027.



Attend the Public Open House

The State Highway Administration will hold a public open house, 6-8 p.m. Wednesday, July 31, 2024, at the Grace Episcopal Church, 1607 Grace Church Rd, Silver Spring, MD 20910. The open house will provide attendees with an opportunity to view both project's details on maps and displays. Project team members will be available to listen to your feedback and answer questions. This information may be used to improve and advance the development of both projects. There will be no formal presentation. You may arrive at any time during the open house hours and walk through the display area at your own pace.
